CLIENT INFORMATION AND FEE SCHEDULE

Please refer to this information provided below regarding policies for billing and cancellations.

BILLING FOR SPEECH/LANGUAGE AND PROCESSING DIAGNOSTIC EVALUATIONS

Payment for evaluation will be required at the completion of the evaluation. The enclosed Acknowledgment must be returned with a completed Case History form, Permission to Communicate form and Child Information form prior to your scheduled appointment.

No written reports will be provided without full payment.

BILLING FOR THERAPY SERVICES

An itemized bill reflecting the dates of session received, procedural code and a diagnostic code will be provided at the end of each month. An emailed version will be sent to you unless you notify us that you would prefer a paper copy. Please let us know which one you would prefer. Payment can be made by check or by credit card through either Paypal or Venmo.

Payment of your fee is due in full by the fifteenth of the month. A late charge of **\$15.00** will be imposed if payment in full is not received by the thirtieth of the month following rendering of services. **Services will be put on hold** if full payment is not received by the 30th of each month. This policy will be enforced.

OTHER CHARGES

We cannot provide quality services without some consultation and written accountability of our efforts. Consultation with parents, physicians and teachers, and additional written reports of and progress notes will be billed at our hourly rate. Phone consultations in excess of 30 minutes will be considered professional consultation and could be charged at our hourly rate.

CANCELLATION

Once a therapy schedule has been set, that time is being reserved for you. If you must cancel an appointment, we require at least **4 hours notice**. The speech-language pathologist must have received the message before your session or it will be considered a broken appointment. **If your child receives therapy at school** and will be going on a field trip or is sick, we **must** have notification the day before in order for you to not be charged for a missed appointment.

If you must cancel a morning appointment, please call the speech-language pathologist the day before or before 8:00 a.m.

INSURANCE
